ACCESS (ASSAULT CARE CENTER, AMES): Rent and utility assistance. Can provide other supports as well. To be eligible, you must be a survivor of domestic abuse, sexual assault, or violent crime. Housing helpline: 1-855-696-2980

CHRIST COMMUNITY CHURCH (AMES): Rent and utility assistance when funds are available. Must be an Ames resident. Documents required: Rental assistance needs photo ID, lease/rental agreement with landlord's information. Utility assistance needs a utility bill. Appointments are in-person on Wednesdays, 1-3 pm. **LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM (LIHEAP)& LOW-INCOME HOME WATER ASSISTANCE PROGRAM (LIHWAP)** (AT MICA, AMES): Utility & water assistance. These programs are accepting applications. If you are approved for LIHEAP, a one-time payment will be sent to your heating vendor. You also will be protected from shut-offs. LIHWAP is crisis water assistance for disconnects on your water bill. Story County enrollment phone number: 515-956-3333.

ST. PATRICK'S "GOOD SAMARITAN" FINANCIAL ASSISTANCE PROGRAM (NEVADA): Rent, utility, and gas assistance. This program is for residents of eastern Story County: Must live on east side of I-35 (Cambridge, Collins, Colo, Fernald, Maxwell, McCallsburg, Nevada, Roland, Zearing). Provide rent and utility assistance every 6 months (up to \$200). Provide gas assistance for work or medical appointments only every 3 months. Students are not eligible for the program. Landlord and utility company information is required for those requesting rent or utility assistance; driver's license is required for those requesting gas assistance. 515-382-2974

**ST. THOMAS' "LOVE YOUR NEIGHBOR" PROGRAM (AMES): Rent and utility assistance**. THE BRIDGE HOME (FORMERLY EMERGENCY RESIDENCE PROJECT, AMES): Continuum of care includes street outreach, emergency shelter for men, women, and families, supportive housing, rapid rehousing and active case management. Clients qualify by participating in a coordinated entry intake. Examples of assistance for people in TBH programs may include application fees, security and utility deposits, moving costs, case management, connecting to legal assistance, and credit repair. All financial assistance is paid directly to landlords and service providers. **STORY COUNTY GENERAL ASSISTANCE (AMES): Rent and utility assistance.** Help can be accessed 1 x in 6-month period or up to 3 consecutive months if there is a medical reason an individual is unable to work. The general assistance application is on the Story County website (https://www.storycountyiowa.gov/345/General-Assistance). The office is open to the public 8:00 am to 4:30 pm. Appointments to fill out applications are required. Please call 515-663-2930 to schedule an appointment.

GOOD NEIGHBOR EMERGENCY ASSISTANCE (AMES): Emergency assistance with gas, food vouchers, CyRide tickets, phone cards, internet, and phone bills. **CITY OF AMES – HOME Program Homebuyer Assistance Program:** This program is now accepting preliminary applications. To be eligible, households must be at 80 percent or less of the Ames median income limits. **WOMEN UNITED:** This program offers free financial management workshops for women in communities throughout Story County, as well as one-on-one mentoring. WORKFORCE RETRAINING (Training is available in Manufacturing, Welding, Healthcare Patient Services, C.N.A.-Basic & Advanced, Construction, Maintenance Tech/Electrician, CDL, Phlebotomy, IT Help Desk, Advanced PLC, Dog Grooming, Administrative Support Professional, Sterile Processing Supply Tech.): DMACC, Ames Chamber, and Story County are partnering to offer these retraining programs. The classes are free for Story County residents 18+ with a diploma or high-school equivalency

**(GED or HiSET).** Classes take place at DMACC campuses. Classes are 5-15 weeks long depending on the course. Supports available include transportation assistance (gas card each week you attend a class), childcare assistance (case-by-case), and cash stipend (\$150 half way through, \$150 at end of class, \$300 after working a job in Story County for 30 days).
